## **Toxic Substances Control Act**

The U.S. Environmental Protection Agency recently restricted the use of several substances under the Toxic Substances Control Act. Atkins & Pearce products are compliant with these new regulations. Based on the disclosures of our suppliers, the only restricted substance that appears in Atkins & Pearce products is the following:

- Astra 701 PVC Tubing (PIP 3:1)

Per the recent rulings, we are only selling this product to customers who can demonstrate that they are using it for new or replacement parts for motor or aerospace vehicles or specialized engine air filters for locomotive and marine applications (as specified by 40 CFR 751.407(b)(1)(iii) and 751.407(b)(1)(v)).

## **California Proposition 65**

In accordance with the State of California Safe Drinking Water and Toxic Enforcement Act of 1986 ("Prop. 65"), customers of Atkins & Pearce must include warnings on any products that contain the substances set forth in Prop. 65 and subsequently sold to California consumers. We have not specifically analyzed our raw materials and products for these chemicals. However, we work closely with our vendors to determine if any warnings are necessary.
